WHAT IS THIS ALL ABOUT?

In a continent that exports luxury cheese and foie gras, over 1 in 4 Europeans struggles to afford healthy food.

The European Citizens' Initiative (ECI) on the Right to Food is now officially registered. This is not just another petition, it's the only democratic tool that can push the European Commission to act. Concretely, ECIs allow citizens from across EU member states to collectively propose new legislation by gathering at least one million signatures, giving them a direct voice in shaping European policy.

We demand binding EU legislation to:

- Guarantee the **Right to Food for all**
- Build fair, sustainable food systems
- Put people, animals and the planet before profit

The campaign starts on the 7th of January, join the coalition now.

WHY THIS, WHY NOW?

Hunger is not an accident, it's a policy failure.

Across Europe, families queue at food banks while prices soar and corporations make record profits. Farmers are disappearing, workers are exploited, and children rely on ultra-processed junk because real food is out of reach.

The Right to Food is recognised in international law, but without political action, it's an empty promise. This ECI is our chance to turn that right into reality.

What would change?

- Every EU policy would have to respect the Right to Food
- Public money would support local, high-welfare, nature-friendly farming, not destructive agribusiness
- Social protection would guarantee dignified access to healthy food



WHAT ARE WE CALLING FOR?

We are building a legal and political campaign to:

- Enshrine the **Right to Food** in EU law
- Guarantee access to healthy, culturally appropriate food
- Support small farmers, food workers, and local producers
- Replace charity with **dignity-based systems**
- Align EU policy with **UNDROP** and climate commitments

- **2026:** Mass mobilization & political pressure
- **2027:** Submit to the Commission — Public hearings — Push for legislation
